
Note about language and terminology

- Identity-first vs person-first language
- APA guidance not clear
- Autistic community suggests (mostly?) identity first (e.g., Keating et al., 2022)
- Be aware of the impact of the language we use (Bottema-Beutel et al., 2021)

Behavioral Intervention (aka ABA)

Enacts behavior change through shaping via reinforcement and punishment

Common intervention for autistic children

- Research shows positive effects
 - Though small effect sizes and very limited longitudinal studies

Concerns about ABA

- Goals: Goal of ABA often to make autistic person seem "less autistic" or "more neurotypical"
 - Promotes "masking"/"passing"
 - May not genuinely improve quality of life
- Methods: ABA procedures can include aversive punishment, withholding of praise or rewards, planned ignoring of distress, and use of external rewards (e.g. candy, stickers) as well as an emphasis on compliance
- Outcomes: Outcomes of ABA are unclear and incompletely studied
 - Evidence weaker than assumed
 - Little empirical work on long-term outcomes
 - Almost no work on adverse effects of ABA
- Misc: Several other concerns with ABA and ABA industry (private equity, RBT training/supervision)

STRENGTHS OF NDBIs with Regard to Neurodiversity

- Co-construction & agency in intervention experience
 - Child choice
 - Family partnerships
 - Acknowledge child's internal states (preferences, attitudes, motivations)
- Use of a strengths-based approach
 - Build upon existent strengths & boost confidence
 - Developmentally appropriate goals
 - Do not explicitly focus on extinguishing/reducing behaviors
- Emphasis on naturalistic skill building
 - Everyday routines
 - Natural reinforcement
 - Often looks and feels like play time (should arguably even be fun!)

Strategies to Improve NDBIs

Center Autistic Voices

- Goals should promote quality of life and not conflict with an autistic identity or "way of being"
- Seek out autistic consultants (and/or interventionists) to evaluate intervention goals, intensity, implementation
- Psychoeducation about neurodiversity to clinicians, families, peers, etc.

Assess Social & Ecological Validity

- What does the intervention recipient (not just the family or clinician) think of the intervention?
- Use preference assessments or other observational assessments (Hanley, 2010) to examine social validity in young children who cannot easily report on their preferences
- Research in community organizations

Research Design

- Community-based partnerships
- Adaptive design
- Adverse event monitoring
